CALL FOR POSITIONS

The University of Wrocław opens a call for **5** positions of **adiunkt**, **asystent**, or **wykładowca** (either temporary employment for a maximum of four years or permanent position) at the Mathematical Institute of University of Wrocław. The employment will begin on October 1, 2021.

1. To be eligible the candidates should comply with the Polish law: *Prawo o szkolnictwie wyższym i nauce z dnia 20 lipca 2018r. (Dz. U. 2018, poz. 1668 ze zm.)*.
2. Position: either research and teaching or teaching.
3. Fields of science: Natural Sciences, discipline of science: Mathematics.
4. Working hours: full-time position.
5. The results will be announced before **30 June 2021**.
6. Candidates for the **adiunkt** position should demonstrate research achievements published in very good mathematical journals and the scientific activity after obtaining the PhD degree, indicating the perspectives for obtaining habilitation. Activity in applying for grants will be highly assessed. A list of the names and email addresses of reviewers which may be requested additionally by the Employment Commission should be included. These recommendation letters will be treated as confidential i.e. available only to the members of the Commission.
7. Candidates for the **asystent** position should demonstrate documented research achievements (written PhD thesis or part of it, reviews of the thesis or opinions on the degree of its completeness, published articles, information on the articles accepted for publication). A candidate will be hired as **asystent** for four years, beginning on October 1, 2021. A candidate without the PhD degree should provide PhD supervisor's opinion stating when the thesis has been (or will be) submitted.

In case that neither of candidates fulfills the criteria, the University reserves the right to close the competition without employing anybody.

The application together with the required documents should be sent **in the electronic form only (in pdf format)** by **June 4, 2021** to the following address: **praca@uwr.edu.pl**

Once the results of the hiring process are announced, the candidates will be asked to submit their original documents.

Documentation required:

- a cover letter addressed to 'JM Rektor Uniwersytetu Wrocławskiego'
- CV
- research and teaching statement, including research plan and information on other candidate's achievements (incl. e.g. organisational)
- a copy of PhD or MSc diploma
- the list of publications
- electronic versions of candidate's publications (including PhD thesis or a part of it)

- two recommendation letters; the recommendation letters should be sent only in the electronic form directly, without the intermediary of the candidate, to the President of the Commission Professor Tomasz Jurdziński at Tomasz.Jurdziński@uwr.edu.pl and to the Vice - President of the Commission Professor Grzegorz Karch at Grzegorz.Karch@uwr.edu.pl The recommendation letters will be available only to the members of the Employment Commission and will be treated as confidential.

- in case of candidates who have been already employed as an adiunkt, a research plan shall be attached, related to the perspectives of obtaining habilitation.
